FUNDS OF FAM THAT ARE HELD UNDER THIS ARRANGEMENT ARE SUBJECT TO INCREASE OR DECREASE FOR AN ALLOCABLE SHARE OF THE APPRECIATION OR DEPRECIATION IN FAIR VALUE OF THE SPECIFIED INVESTMENTS HELD IN THE FOUNDATION'S INVESTMENT PORTFOLIO. GENERALLY, FAM FUNDS ON DEPOSIT ARE REPAYABLE BY THE FOUNDATION WITHIN 30 TO 60 DAYS AFTER RECEIVING FAM'S WITHDRAWAL REQUEST. DURING 2019, MANAGEMENT RECORDED ESTIMATED APPRECIATION OF \$309,226, WHICH INCREASED THE ESTIMATED FAIR VALUE OF FAM'S CUMULATIVE AMOUNT ON DEPOSIT TO \$2,599,736 AT DECEMBER 31, 2019.

FAM ESTABLISHED AN ENDOWMENT DURING 2016, UPON AGREEING TO ACCEPT A RESTRICTED CONTRIBUTION FROM A DONOR. THE AGREEMENT WITH THE DONOR PROVIDES THAT THE ENDOWMENT FUNDS MAY BE POOLED WITH THE FOUNDATION'S INVESTMENT PORTFOLIO FOR INVESTMENT MANAGEMENT PURPOSES. ACCORDINGLY, THE ENDOWMENT FUND REPORTED IN SCHEDULE D, PART V IS HELD BY THE FOUNDATION.
